The Wildlife Habitat Restoration and Management Specialist is a full-time, professional and technical position responsible for carrying out the Tribes' wildlife habitat restoration, enhancement and management objectives on the Flathead Reservation. The primary function of this work relates to the Tribes' SKQ settlement mitigation efforts.

The Specialist duties include, but are not limited to, the following:

- Conducts all aspects of wildlife habitat restoration and enhancement projects, including planning, sequencing, project management and oversight, implementation, monitoring, and reporting to ensure successful restoration and enhancement of Reservation lands impacted by human activities; a Manages wildlife habitat on wildlife conservation lands including fence maintenance, hydrology, invasive plant management, prescribed fire planning, and working with adjoining land owners to enhance habitat objectives and resolve conflicts.
- Acts as a key member of the SKQ Wildlife Mitigation and Habitat Restoration Team, involved in wildlife habitat restoration planning and implementation and long-term habitat management.
- Restoration efforts will be concentrated primarily on wetland, riparian and associated upland habitats.
- Coordinates closely with and provides information and assistance to the various divisions of the Natural Resources Department (NRD), the Tribal Preservation
- Department (TPD), in field or office assignments; a Works closely with the Tribal Natural Resources and Preservation Departments, and both Tribal Culture Committees, to develop culturally sound plant restoration plans; a Maintains confidentiality of sensitive plant information as directed by the Culture
- Committees and TPD; a Coordinates with other Tribal restoration projects (ARCO, Highways, BPA, Bison Range etc.) to facilitate efficient use of Tribal staff, contractors, plant propagation facilities, and other Tribal resources;
- Conducts and directs vegetation inventories in project areas, including on-theground reconnaissance and record examination regarding such items as: o Vegetative condition and potential, o Non-point pollution sources,
- Wetland, riparian and grassland classifications, o Progress toward restoration goals;
- Compiles quarterly and annual summary reports and maintain daily records for project activities;
- Functions as an interdisciplinary team member, providing input for environmental analysis in the restoration and mitigation areas;
- Supervises trainees, technicians, crews and contractors in the field;

- Is actively involved in the implementation of restoration projects, including hand planting, plant salvage and planting with heavy equipment, hand seed collection, weed control, and other equipment operation, such as site preparation, seeding, fertilizing, and mulching;
