Respondents to this RFP must submit one original proposal. Proposals should be clearly marked "Indirect Cost Rate Proposal" and emailed to the contact person listed above.

5. Timeline

NAFWS needs the project submitted to the Federal Agency by June 1 2023.

6. Elements of Proposal

A submission must include, at a minimum, include the following elements:

- Description of the firm that includes:
 - General overview of your firm
 - Primary and secondary points of contacts within your firm; name(s), email address, phone numbers and credential(s)
 - Number of full-time employees you have and how many will be assigned to this project with their level of Indirect Cost Rate expertise. Please include any use of sub-contractors.
- A one-page narrative outlining the firm's strengths and distinguishing skills or capabilities as they relate to Indirect Cost Rate Proposals and experience working with Native American clients.
- How will your firm work with and communicate with the appropriate Federal Agencies?
- Please provide a detailed work plan, project schedule, deliverables and timeline.
- Please provide (3-5) references where project work your firm has performed and completed that was similar to our project needs, goals and objectives.

7. Evaluation Criteria

The successful respondent will:

- Have the infrastructure to complete all aspects of the Indirect Cost Rate Proposal in a timely manner.
- The education, experience (a minimum of 5 years organizational experience), knowledge, skills and qualification of the auditors who will be available to provide these services.
- The expertise working with Native American and/or Alaska Native Tribes.
